

## PARTICIPATION NOTIFICATION BY BLACKROCK INC.

**Brussels, Thursday April 27, 2017, 8h00 CET** --- According to the Belgian transparency legislation in force (Law of May 2, 2007), BlackRock Inc. (55 East 52nd Street, New York, NY, 10055, U.S.A.) has notified Solvay SA that on April 20, it crossed downward the statutory declaration threshold of 3% of the existing voting rights emitted by Solvay SA.
