- Op 25 mei 2017 het aantal aangehouden directe stemrechten van BlackRock Inc. de statutaire drempel van 3% opwaarts heeft overschreden. Inclusief stemrechten aangehouden via gelijkgestelde financiële instrumenten, hield BlackRock Inc. 3,14% aan van de bestaande stemrechten van Solvay nv.
- Op 26 mei 2017 het aantal aangehouden directe stemrechten van BlackRock Inc. de statutaire drempel van 3% neerwaarts heeft overschreden. Inclusief stemrechten aangehouden via gelijkgestelde financiële instrumenten, bleef BlackRock Inc. boven de statutaire 3% drempel, met 3,06% van de bestaande stemrechten van Solvay nv.
