

PARTICIPATION NOTIFICATION BY BLACKROCK INC.

Brussels, Friday May 25, 2018, 08h30 CEST --- According to Belgian transparency legislation (Law of May 2, 2007), BlackRock Inc. (55 East 52nd Street, New York, NY, 10055, U.S.A.) has notified Solvay S.A. that:

- On May 17, 2018 BlackRock Inc. crossed upward the 3% statutory threshold for direct voting rights, holding 3.37%. Including equivalent financial instruments, the total voting rights stood at 4.88%.
