Solvay is committed to protecting your privacy under the applicable legislation in relation to the protection of information regarding identifiable individuals, including the General Data Protection Regulation 2016/679, as well as any new European or local legislation that may come into force during the use of the Solvay Recruiting tool in order to provide a secure online experience.

We seek to ensure that our systems are functioning properly and will use reasonable and customary efforts to protect your personal information in our possession provide to us through the use of the Solvay Recruiting tool.

Basic Definitions: Here are some basic definitions that will help in reviewing this document. Unless the context clearly requires otherwise:

- When we say "you" (and its variations) we mean you as an individual.
- When we say "we" or "Solvay" (and their variations: "Solvay Group" or "Group") we mean Solvay SA and its subsidiaries with headquarters address at Solvay SA, located at : Rue Ransbeek, 310, B-1120 Brussels, Belgium

This Privacy Policy describes:

- The types of Personal Information (defined below) we may collect or that you may provide when you register with, access, or use the Solvay Recruiting tool.
- Our practices for collecting, processing, maintaining, protecting, and disclosing the Personal Information

This Privacy Policy applies only to Personal Information we collect in the Solvay Recruiting tool.

This Privacy Policy DOES NOT apply to Personal Information that we collect offline or on any other Solvay apps or websites, including websites you may access through this tool.

Our websites and apps or any other third parties have their own privacy policies, which we encourage you to read before providing information on or through them.

Please read this policy carefully to understand our policies and practices regarding your information and how we will treat it. If you do not agree with our policies and practices, do not register with, or use the Solvay Recruiting tool. By registering with, or using the Solvay Recruiting tool, you agree to this Solvay Recruiting tool Privacy Policy. This Privacy Policy may change from time to time. Your continued use of the Solvay Recruiting tool after we revise this policy means you accept those changes, so please check the policy periodically for updates.

Data Collection

Solvay Recruiting tool contains several key features that may collect Personal information:

- to apply online
- to configure job alert
- to see your previous applications
- to allow us to handle your application.

We may collect and process some personal information relating to you such as name, e-mail address, and phone number as well as your Curriculum Vitae containing information like your personal address, hobbies, education, qualifications and work experience. Please ensure that all information you submit is accurate and not misleading.

We will be unable to consider you for employment if you do not provide us with these details. In some countries, we collect personal data about you from third parties, such as references supplied by former employers, subject to applicable local law requirements.

We might use your e-mail address to invite you to participate in a follow-up survey on the recruitment process. Your participation in such a survey is completely voluntarily.

The lawfulness of such collection and processing of your Personal Information as it may pertain to your geographical localization will always be based on your prior express consent, it being specified that participation in using the Solvay Recruiting tool is completely voluntary and is your choice.

The scope and features of the processing of your Personal Information will depend on the options that you activate of not on your account (and thereafter at anytime by adjusting the settings on your user account) for your use of the Solvay Recruiting tool.

Your consent will be directly collected through the use of a Cookie

By accepting the request for using Cookies when you connect for the first time to a website, the following Cookies policy applies:

How do we use Cookies

Solvay receives and records information, which may include Personal Information, from your browser when you use the Solvay Recruiting tool. We use a variety of methods, such as cookies to collect this information, which may include your (1) IP-address; (2) unique cookie identifier, cookie information and information on whether your device has software to access certain features; (3) unique device identifier and device type; (4) domain, browser type and language, (5) operating system and system settings; (6) country and time zone; (7) previously visited websites; (8) information about your interaction with our Solvay Recruiting tool such as click behavior, purchases and indicated preferences; and (9) access times and referring URLs.

Cookies are small text files that contain a small amount of information that is downloaded on your device when you visit the Solvay Recruiting tool. Cookies are then sent back to the original Solvay Recruiting tool to other websites or applications that recognize those cookies upon each subsequent visit. Cookies are useful because they allow a website or application to recognize your device and to put this information in connection with other information about you. Recipients of your Personal Information and international data transfers

We will process your Personal Information in accordance with the Solvay Recruiting tool Privacy Policy you have consented to. Solvay may communicate your Personal Information only to the authorized persons within Solvay and its subcontractors who/which need to know such Personal Information in order to accomplish their respective missions contributing to fulfilling the Purposes, who undertake to ensure the strict confidentiality of the Personal Information in their possession (the "Recipients").

Retention of your Personal Information

We shall retain your Personal Information according to the applicable laws:

- In the event your application is unsuccessful, and if you have not applied to another position for six months (US: 36 months), it will be automatically deleted from our database. You may modify it as often as you want.
- If you gain successful employment with us we will retain your personal data and transfer this into your personnel file. A separate privacy notice will be provided in these circumstances.

- Upon withdrawal of your personal information we will no longer consider you as a candidate in the recruiting process for a specific job opening and will delete your personal data after the applicable retention period
- If you have been referred to us by an agency or a Solvay employee we will only keep your data upon your consent to this privacy policy. If you opt out, we will immediately delete your data. If you neither opt in nor opt out, your data will be deleted after 14 days.

Please do not transmit sensitive information to us such as your ethnic origin (this can however be provided voluntarily by applicants in the US at the applicable application phase), your political opinion, your philosophic and religious opinion, your membership of a trade union or a political party, your physical and mental health, your sexual orientation, a legal proceeding, your National Identity number or your Social Security number.

Your rights

You have the right to request from us access to, rectification and removal of Personal Information, as well as restriction of the processing concerning you. You also have the right to object to processing as well as the right to data portability.

Since the collection and processing of your Personal Information is based on consent, you have the right to withdraw your consent at any time, without affecting the lawfulness of processing based on consent before its withdrawal.

Governing Law and competent jurisdiction
