

SOLVAY CHEMICALS MANUFACTURING SITE INSTRUCTIONS

Directions for Freight Pickup

Thank you for accepting our tender and agreeing to haul freight for Solvay Chemicals. Solvay Chemicals' Deer Park Manufacturing facility's address can be found in the footer of this document.

Below is some information about the requirements currently in force at our La Porte, TX (Deer Park) facility:

LOADING HOURS: MONDAY – FRIDAY, 8 AM – 3 PM CENTRAL TIME

Please note that the driver must reference the **SOLVAY ASSIGNED PICKUP NUMBER** to be admitted to the plant. Please also note that all carriers who are picking up packaged material, must bring with them **THREE(3) SPREADER BARS AND A MINIMUM 6 STRAPS** in order to properly secure the load to prevent damage to the product during shipment.

For everyone's safety, please be advised that only the driver will be allowed on and into the plant site. This means: **NO PETS, NO CHILDREN, NO ADDITIONAL PASSENGERS ALLOWED.**

PROPER PPE REQUIRED FOR THE DRIVERS INCLUDES:

- LONG SLEEVE CLOTHING TO COVER THE ARMS
- LONG PANTS CLOTHING TO COVER THE LEGS
- CLOSED TOE SHOES (NO FLIP FLOPS OR CROCS)
- HARD HAT
- SAFETY GLASSES
- FACE COVERINGS

PLEASE NOTE: DRIVER WILL BE TURNED AWAY AT CARRIER'S COST IF THEY ARE MISSING ANY OF THE ABOVE PPE.

COVID-19 PRECAUTIONS

As part of our COVID prevention plan, **all drivers must wear face coverings and will have their body temperature scanned using an IR thermometer (IRT).**

Please be advised that individuals taking certain medications or who have recently drank, eaten, or been involved in physical activity, could have a higher-than-normal temperature. Secondary testing with a disposable thermometer may be required as a result. If possible, avoid these things for 30 minutes prior to having your temperature taken upon entering the plant.

If the forehead temperature is greater than 100°F the second time, the person's temperature will be checked with an oral thermometer. **If it is still >100°F, the person will be denied access to the site** and their name/company name will be recorded and reported to the Solvay HSE Manager. If this happens, the driver should contact their dispatcher who in turn should contact their logistics contact at Solvay.

Additionally drivers will be asked to fill out a **COVID questionnaire** during their check-in process and they are **asked to include their phone number**, which will be used in the event that we need to contact them specifically related to the Coronavirus situation at our Site.
